Disbursement of 50% Grant for FY: 2020-21 for ongoing fellows working under DBT-JRF Program

DBT-Junior Research Fellowship is now being managed by Regional Center for Biotechnology through its HRD Project and Management Unit (HRD-PMU).

RCB will start the disbursement of fellowships to the concerned universities and institutes where the fellows are perusing their PhD through Public Financial Management System (PFMS).

All the universities/institutions receiving funds from DBT (Fellowship under the DBT-JRF Program) will use EAT module of PFMS and shall take immediate actions on the following issues:

1. Implementation of EAT module in Universities/Institutions to receive funds under the above mentioned program.
2. Universities/Institutions who are already registered on PFMS need to add the **Scheme Code: 0150 – Biotechnology Research and Development**, and for funding agency, **select RCB** (not Central Govt. or State Govt.) and inform us on email ID: hrd.pmu@rcb.res.in along with the mandate form at the earliest.
